Service Period

Service Fee

The Client agrees to pay _____ to the Service Provider for the services provided under this Contract. This payment shall be made in _____ equal installments and the first installment shall be due on _____. Balance installments are paid monthly, on the _____ of each month at the latest.

Default and Termination

If the Client is not satisfied with the service provided, he/she immediately informs the Service Provider in writing with the reasons of dissatisfaction. If defects in services are not rectified, the Client may terminate the Contract by paying the price of all services provided. Termination is notified to the Service Provider in writing.

In the event that any of the parties hereto become in default under this Contract, the defaulted Party shall reimburse the other party for any expenses reasonably incurred by the non-defaulting party.

Confidentiality

The information shared between the Parties hereto, the financial transactions, proprietary information, statistical data, including the terms and conditions contained in this Agreement, except public or disclosed information shall constitute confidential information. The recipient of such confidential information shall keep confidential the confidential information from any third party unless prior written consent is given by the owner of said confidential information. The foregoing, notwithstanding, in the event that the recipient of the confidential information is legally compelled or required by any competent authority to be disclosed, the holder of confidential information shall notify the other so the latter may be able to seek a protection order or avail itself appropriate remedies or waive in compliance the provisions hereof. The provisions of this section shall survive the termination of this Contract for whatever reason.

Other Provisions

- **Non-waiver** - The failure or neglect of either party to insist upon the strict compliance with and performance of any of the terms and conditions hereof shall not be deemed as a waiver of any rights that said party may have. Should any party exercise a waiver, the said party shall put said waiver into writing.
- **Modifications** - No modifications or alterations to this agreement shall be considered as having been made unless both parties set such modification in writing and signed by both parties.

- **Relativity** - This Contract inures the benefit of, and is binding upon, the successors and assigns of the parties hereto.
- **Separability Clause** - In case any of the provisions or covenants herein be considered invalid by a competent court, such invalidity shall affect only the said provision. The remaining provisions not affected by said invalidity shall remain valid and enforceable.
- **Assignment** - Neither party may assign or transfer their rights or obligations under this Contract without the prior written consent of the other.
- **Entire Agreement** - This Contract represents the arrangement agreed upon by the parties. Any agreements existing prior to this agreement shall be superseded by this Contract.
- **Governing Law** - This Contract shall be governed and construed in accordance with the laws, rules, and regulations of the State of _____.

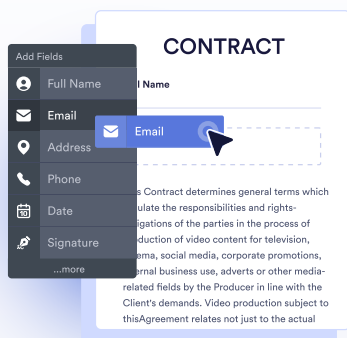

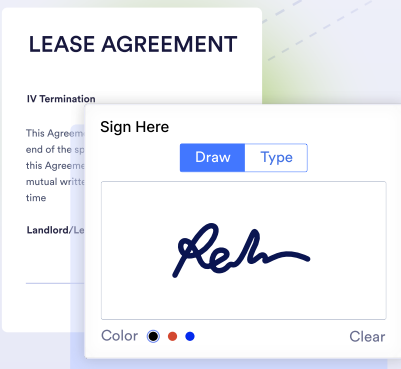
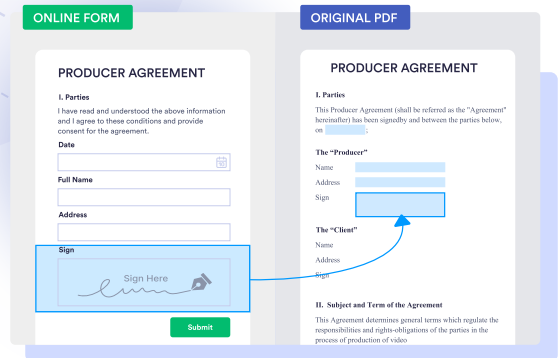
